Saturdays, May 12th – September 29th

Sulphur Springs is excited to offer the community two markets, to fill a fun and festive atmosphere downtown. Daylight Market will run during the morning hours for consumable products grown or produced by approved vendors. Daylight Market will be located on N. Gilmer, between Atkins Street and Jefferson Street. Celebration Market will run in the evening hours for handmade arts & crafts, and will be located on the plaza. There are limited spaces available for reservation at both markets. Any application received after the capacity of market is reached, will be placed on a wait list. All applications are subject to review and acceptance by market committee. Application does not guarantee vendor acceptance.

Celebration Market prohibits marketing activities during market hours. Any fundraiser will have to be approved by the market committee and is limited to 2 market dates per season.

To ensure a reserved spot for the markets, there will be a \$140.00 fee for season. Fees are required to be turned in before the market season begins. Food handlers require inspections and are required a \$300 fee for the season. Fees are non-refundable.

Market Committee will review all applications and will contact prospective vendors with further details and instructions. Terms and Conditions for Celebration Markets

1. Only approved vendors are allowed to sell at the Celebration Markets in their reserved spots. Spots are reserved for the whole season.
2. Vendors shall sign an agreement to terms and conditions of these rules. By signing, applicants acknowledge the rules of the Celebration Markets.
3. Vendors are required to attend AT LEAST three-quarters of the market schedule. Any less will result in review and possible removal from market by committee and a waitlisted applicant will be contacted. Emergencies or extenuating circumstances will be taken under consideration.
4. Vendors shall supply all their own materials to run their booths, such as take-away containers, tables, canopy, chairs, etc.
5. No firearms, drugs or alcohol allowed.
6. Vendors must set up no earlier than one hour before market start time and no later than 30 minutes before start time. Vendors must stay for the duration of their designated market times unless due to extenuating circumstances or they sell out.
7. After unloading, vendors must park in any public parking OFF of the plaza in order for patrons to have access to market.
8. Vendors have one and one-half hour to break down their booths and vacate market place. Vendors are prohibited in using the public trashcans for large boxes or unused/unsold produce or product.
9. Vendors may only sell products previously approved by committee. Vendors must seek committee approval for any additions.
10. Vendors are responsible for pricing and display of their product.
11. All items cooked on site are subject to inspection by a licensed food/health inspector and all safety rules applicable to food-handler regulations.
12. Designation and allocation of spaces at the markets are determined by the market committee and may be changed at any time if the market committee deems it necessary.
13. Vendors may only sell within the space designated to them by the Market Committee. Standing in front of spaces hawking customers and pushing samples will not be allowed.
14. Vendors may not sublet or trade vendor spaces.
