Celebration Market 2018 is coming! With new hours and new programs in store for the season! There are limited spaces available for reservation. Any application received after the capacity of market is reached, will be placed on a wait list. All applications are subject to review and acceptance by market committee. Application does not guarantee vendor acceptance.

Any fundraiser will have to be approved by the market committee and is limited by the number of fundraisers applying in order not overcrowd market area.

To ensure a reserved spot for the market, there will be a ONE TIME \$140.00 fee for the season and includes the Christmas Market which runs the first Friday night in December (in conjunction with the Christmas Parade). Payment arrangements can be made if needed. For anyone who would like to make it to market less frequently, there is a \$15.00 placement fee per market and must be paid the days you arrive. (This excludes food handlers) There are no reservations for walk-up vendorship. Food handlers require inspections and are required a \$300 fee for the season. Fees are non-refundable.

Market Committee will review all applications and contact prospective vendors with further details and instructions.

ALL Market Vendors will be put on the texting database, REMIND, for communication purposes during the season.

Pages 2 and 4 must be filled out for Market consideration.

Terms and Conditions for Celebration Market

1. Only approved vendors are allowed to sell at the Celebration Markets in their reserved spots or assigned spots.
2. Vendors shall sign an agreement to terms and conditions of these rules. By signing, applicants acknowledge the rules of the Celebration Market.
3. Vendors shall supply all their own materials to run their booths, such as take-away containers, tables, canopy, chairs, etc.
4. Canopy's CAN NOT be anchored by spikes. They need to be anchored by weights.
5. No firearms, drugs or alcohol allowed.
6. Vendors must set up no earlier than 3pm before market start time.
7. Vendors have one and one-half hour to break down their booths and vacate market place.
8. Vendors may only sell products previously approved by committee. Vendors must seek committee approval for any additions.
9. Vendors are responsible for pricing and display of their product.
10. All items cooked on-site are subject to inspection by a licensed food/health inspector and all safety rules applicable to food-handler regulations.
11. Designation and allocation of spaces at the market will be determined by the market committee and may be changed at any time if the market committee deems it necessary. Reserved spots for the season are first-come-first serve at the time of application approval.
12. Vendors may only sell within the space designated to them.
13. Vendors may sublet spots with a completed application by sub-vendor and approval by committee.
