As mandated by House Bill 2309 of the 79<sup>th</sup> Legislation, two weekdays must be open for 12 hours during the regular early voting period. Therefore, early voting by personal appearance will be conducted between the hours of 7:00 a.m. and 7:00 p.m. on Wednesday, June 3, 2009 and Thursday, June 4, 2009.
